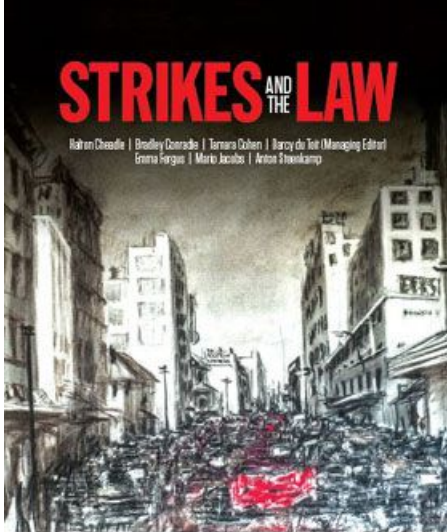


Get to grips with the law on strikes

Strike action is an area of labour law where the stakes are high. The Labour Relations Amendment Bill, 2017, published on 17 November 2017, attributes a misalignment between the law on strikes and action taken by parties during industrial action, as the root cause for protracted and often violent industrial action. The publication is therefore a critical read for labour law practitioners, HR/IR managers, CCMA commissioners, trade unions and academics.
